LETTER FROM...

Greetings from the West CAP Board of Directors and Staff;

We are pleased to present West CAP's Annual Report for Fiscal Year 2016.

At the onset, I should note the last West CAP Annual Report we produced was dated 2014, so you might wonder what happened to 2015. Fair enough. This year we decided to tie our annual report to our fiscal year, which runs from July 1 through June 30th, instead of the calendar year as we have in the past. In that transition, the first report to follow calendar 2014 is for the fiscal year beginning in July 2015 and ending in June 2016; and fiscal years tend to be named for the year that they end in, so here is our FY 2016 report. While we were at it, we also decided that it made more sense to report the number of people served rather than the number of households because we serve people, not houses.

So, in Fiscal Year 2016, West CAP assisted 25,942 people through its wide array of services. Once again, the services we successfully acquired funding to provide last year included home weatherization, homelessness prevention, temporary housing and case management for those needing to get their lives back on track, skills and literacy training, help in purchasing a reliable and economical car, housing counseling and foreclosure mitigation, safe, decent and affordable rental housing, rent assistance, energy assistance, and access to needed food. In carrying out this work, West CAP also put \$9.5 million to work in the local economy.

As you might imagine, helping people cope with, alleviate, and hopefully to escape poverty is difficult, challenging and often discouraging work. But in a country literally founded on the belief that life, liberty and the pursuit of happiness are inalienable rights, this is work that must be done. The fact that in just this small, rural area, close to twenty-six thousand people received our help, tells us that we have a long way to go to make these founding American principles a reality for all who call this land home.

Now we turn to the future. This is a time of unprecedented unease and uncertainty on many fronts - economic, political, social, and environmental - which will greatly impact our low income families; often those of us who have the fewest resources for resilience. So at West CAP, as we have done for over fifty years, we will do whatever we can to ensure that low income families have a clear voice in the collective choir which makes up this democracy, and which has the duty and responsibility to make our founding values a reality for all.

In the year ahead as in many years past, the Board and Staff of West CAP look forward to working with all of you to help make this a great place to live for all who chose to call west central Wisconsin home.



1965 - West Central Wisconsin Community Action Agency Inc. is born.

Jake Banks is the first Executive Director.

Programs for Employment & Training and Head Start begin.

1967 - Helping Hands marketed crafts for elderly & disabled Persons.

1968 - Project "Outreach" - a hallmark of Community Action.

1969 - 1st Parent Child Center in the nation.



1970's

1971 - The Tri-Coop built several panelized, bolt-together houses.

A set of them served as Impact 7 offices in Turtle Lake.

1974 - The 1st of the nationally CSA-funded Weatherization programs.

From 1972 - 1976, VISTA dentists and hygienists staffed a full-service clinic, providing education and dental services to hundreds of persons per year.

1976 - Patrick Pesek-Herriges becomes Executive Director.



1980's

During 1980-1981 the "Energy Bus" was a highly visible presence at County Fairs, schools and community events.

In 1982, West CAP conducted the first area-wide commodity distribution.

1985 - Start-up of the 4-year Teen Parent Program, combining work experience and case management.

In 1986, West CAP completed "spin-off" of Family Planning to County Health departments.



1990's

1990 - One of the first 24 CCDP Early Head Starts.

1991 - West CAP locally invented the Supportive Housing Program.

1992 - The Jobs and Business Development Program started. Led to 105 business start-ups and 212 jobs.

1995 - TEFAP food distribution began at West CAP.

1995 - Peter Kilde is hired as Executive Director.

1999 - Start-up of the award-winning, nationally-recognized JumpStart Program.



2000's

2001 - Completed renovation of the Crossroads building in Menomonie which included a food business incubator and retail space for the Menomonie Market Food Co-op.

2002 - Start-up of Ideal Auto, non-profit dealership.

2004 - Purchased Stout Road office building in Menomonie.

2005 - Skills Enhancement program began. Adult Literacy followed in 2009.

2002-2009 Purchased or completed 7 multi-family housing projects including Glenwood Commons, 96 bed student housing in Rice Lake.



2010's

2010 - Designated an "Organization of Excellence" by the Annie E. Casey Foundation.

2012 - Launched the Family Table home cooking and nutrition program.

2012 - Relocated the food pantry to the old grocery store building on Main Street in Boyceville. Renovated 4 upper apartments by our Deep Retrofit Program.

2014 - Client Amy Treptow is honored by the US Congress for her submission to the Community Action's War on Poverty Storyteller Contest.

Guest Speaker—Michael Perry, New York Times Bestselling Author, Humorist, and Singer/Songwriter

Michael Perry's bestselling memoirs include *Population 485*, *Truck: A Love Story*, *Coop*, and *Visiting Tom*. His first book for young readers, *The Scavengers*, was published in 2014 and first novel for adult readers, *The Jesus Cow*, was released in May of 2015. Raised on a small Midwestern dairy farm, Perry put himself through nursing school while working on a ranch in Wyoming, then wound up writing by happy accident. He lives with his wife and two daughters in rural Wisconsin, where he serves on the local volunteer fire and rescue service and is an intermittent pig farmer. He hosts the nationally-syndicated "Tent Show Radio," performs widely as a humorist, and tours with his band the Long Beds (currently recording their third album for Amble Down Records). WEATHERIZATION & ENERGY

Weatherization

Weatherization offers a range of services, including insulation and minor repairs. Each home or apartment receives a technical assessment and weatherization work to provide more efficient use of utilities including: insulation of attics, walls and floors; repair or replacement of furnaces; computerized energy audits; air infiltration testing; and a general health and safety inspection.

- Clients Served: 2,048

- Economic Impact: \$3,047,513

Paying bills is not as dreadful as it used to be. The furnace is so much more economical, we are also using less propane compared to other winters. Energy Assistance

The Wisconsin Home Energy Assistance Program (WHEAP) provides assistance for heating costs, electric costs, and energy crisis situations. Utility payments are made directly from the State of Wisconsin to vendors or customers. West CAP administers the program for St. Croix and Pepin counties.

COMMUNITY HOUSING

Community Housing Development Organization (CHDO)

CHDO provides development and asset management of affordable housing units throughout the West CAP service area. Through partnerships with private for-profit businesses and non-profit groups West CAP has developed, acquired or renovated 512 units of housing in Barron, Boyceville, Chippewa Falls, Clayton, Colfax, Downing, Ellsworth, Frederic, Glenwood City, Hammond, Menomonie, New Richmond, Phillips, Rice Lake, Spring Valley, Stanley, St. Croix Falls, and Oskaloosa, IA.

HOUSING ASSISTANCE

The Housing Assistance programs help low-income families by providing a continuum of housing options from transitional housing for persons experiencing homelessness to homeowner services. Housing assistance staff members work to match individuals and families with available program funds and other community resources.

Homeless Prevention Program

- Transitional and Permanent Supportive Housing – help in achieving safe and affordable housing for homeless families, dealing with physical, medical and daily living needs, and developing a plan for long-term stability
- Housing Choice Vouchers – assistance with rental costs in Dunn, St. Croix, and Pierce counties through HUD Section 8 Housing Choice vouchers

Homeownership Program

HUD certified housing counselors assist families in understanding and attaining responsible home ownership. Housing counselors provide several services including:

- Home Buyer workshops
- Down payment and closing cost assistance
- Foreclosure Intervention workshops
- Foreclosure mitigation - finding solutions, understanding options, limited financial assistance

I am currently graduating May 6, 2016 with honors and then going on for my Executive Assistant Associates Degree.

I was in a relationship for three years and never knew that I was being abused by my son's father, both physically and mentally. I reached out to the Bridge of Hope and was placed with Ashlee to help me get away from the abuse. She helped me get into the TBRA Program, which changed my life. I didn't think that I would be so successful with the help of Ashlee and Ann Kohanek. I also had a great landlord Glenice at Cedar Grove Apartments. Glenice wiped my tears on my bad days and let me know how proud she was of me. I can never repay her, Ashlee, or Ann for all their support. These three ladies showed me what it was like to be strong, independent, and successful.



TRANSPORTATION

“I just wanted to share a little story with you that I had recently heard. I happened to be working next to a woman and I mentioned that I had worked for West CAPthis woman was excited to tell me about her JS experience. She was a struggling single mother and was in desperate need of a decent vehicle so she could get to work, however she had NO credit. She applied to the JumpStart program, got a reliable car, made her payments, paid off the car - which got her good credit and she was there-by able to purchase her family farm and raise horses (and have her elderly father live with her and the kids) as well as continue to work full-time. That opportunity was a wonderful experience. She was smiling the whole time she told me her story.”

JumpStart Program

JumpStart helps low income families solve their essential job and family transportation needs by assisting in the purchase of good quality, fuel-efficient cars. JumpStart assistance includes:

- Finding the right car at a reduced price
- Obtaining financing from a local lending institution
- Establishing a fund to cover major repair expenses
- Preventative maintenance training

Food Access and Resources Program

The Food Access and Resources Program addresses food security in our communities by supporting a network of food pantries, soup kitchens, and shelters that provide emergency food assistance. The program provides staff support and TEFAP food distribution assistance to 26 community-based food pantries, 4 shelters and 1 soup kitchen in west central Wisconsin. Each of these outlets provides direct, emergency food assistance to low-income families in their area. Other programs include:

- Administration and coordination of the local food pantry for Glenwood City & Boyceville school districts
- Senior Farmers Market Vouchers – vouchers for low-income senior households to utilize at certified farmers markets and roadside stands
- Commodity Supplemental Food Program – monthly deliveries of food boxes to low-income seniors
- Menomonie Farmers Market - a community marketplace where farmers can generate extra income. It also provides an opportunity for consumers to purchase fresh products directly from area farms, such as vegetables, fruit, eggs, meats, and handmade crafts
- Back-Pack program - West CAP orders and assists the Glenwood City school district to provide weekend backpacks of food for low-income students. This program is solely funded through local Glenwood City Donations and serves on average 30 households per week.

COMMUNITY INITIATIVES

Community Initiatives

Holiday Gift Drive - for children ages birth to 18 years, West CAP helps with gift giving during the Holiday Season to income eligible families in the Boyceville, Glenwood City, and Spring Valley school districts funded by the generous donations of the community and local businesses. We also partner with the schools and churches in these communities to help teach the value of giving to those less fortunate. Some businesses have also made it a tradition to “adopt” families and purchase everything on their wish lists.

Back-to-School Supply Program - for children in Dunn County and the Glenwood City school districts; our program assists income eligible families with supplies for Pre-K to 12th grade. This program is funded by the generous donations of the community and local businesses.

Literacy and Skills Enhancement Program

Literacy – assistance to improve literacy skills for personal, educational or job related goals

Skills Enhancement – case management and financial assistance for low-wage workers enrolling in short-term training to increase job skills and benefits

FOLLOW YOUR DREAMS

Tanya Beyer earns RN degree with help from West CAP

ELMWOOD, WI – Sometimes, stopping to read what's on a bulletin board can make a real difference in your life.

That's what happened to Elmwood native Tanya Beyer in January of 2010. "I was taking classes at Chippewa Valley Technical School in River Falls when I noticed a West CAP (West Central Wisconsin Community Action Agency) flyer on the bulletin board in the hall," she said.

Beyer had earned her Medical Assistant Degree from Minneapolis Business College following graduation from Elmwood High School and at the time was working toward her Associate Degree in Nursing. After reading the flyer, Tanya contacted West CAP and asked if they could help her. They could, and with their encouragement, Tanya enrolled in West CAP's Skills Enhancement Program which provides case management and financial assistance to individuals at or below 150% of the federal poverty level.

"They helped me with mileage costs for attending school as well as daycare expenses. They paid the daycare directly. It really helped me out," she explained adding, "I already had financial aid. If I hadn't, I could have gotten help from West CAP for those expenses as well."

Tanya was working as a Medical Assistant for Hudson Physicians when her husband, Twain was injured on the job. "He hurt his back at work in 2008. At first Workman's Compensation denied his claim, so we were way down in income. That was eventually resolved, but then his back surgery left permanent nerve damage leaving Twain unable to hold a full time job, so now he's a stay-at-home dad," said Tanya.

Obviously the loss of income caused an economic hardship for this family with two small children, Pride age 8 and Kalena age 6. It was then that Tanya decided to go back to school to earn her Associate Degree in Nursing to increase her income. "I graduated in May, and now I work as a registered nurse in Hudson. I have basically the same responsibilities in my position as Assistant to Nursing Supervision, but I have gotten a pay raise because of my education," said Tanya.

Currently she is enrolled in online courses at Capella University earning her Bachelor of Science Degree in Nursing. "I'm so used to going to school now, that I just decided to keep going, so I enrolled in this program," she said with a smile. "It will be a year and a half before I complete my degree, but if I were to ever leave Hudson Physicians, I'll have this additional education." The chances of her leaving Hudson are pretty slim. "I just love my job. I've been there for 17 years. The people I work with are like my family," she added.

Stephanie Stark, West CAP Literacy & Skills Enhancement Coordinator, said, "Tanya has worked very hard to accomplish her goals and help her family. It was a pleasure to have some part in helping her attain her goals." She then provided additional information on what West Cap has to offer. "The West CAP Skills Enhancement Program is designed to assist low-wage, working adults to access short-term training programs that will provide an opportunity to increase wages and gain access to employer provided health insurance.

Short-term training is defined as two years or less for a technical school program, or a condensed training program such as CNA or CDL training. It is not intended for individuals who are enrolled in a four-year degree program unless they hold at least a junior status and will graduate within two years.

Skills Enhancement participants may be eligible for assistance with tuition related expenses, training related transportation costs, and assistance with child care costs incurred while attending school. The Skills Enhancement Program is designed to be an on-going partnership with the client, not a source of one-time assistance. Skills Enhancement Program participants can benefit by attending classes part time so that they can continue to work. They can also increase their earning potential and gain access to employer sponsored health insurance benefits, and increase their wages.

With her new job, Tanya has increased her wages and now is able to support her family. They no longer need financial assistance," noted Stephanie.






Chart of Revenue for FYE 2016


